THE CONTINUING INSURANCE SAGA The Editor recently received a reply from the EAA insurance program's **Falcon Insurance** in response to his complaint to **HQEAA** that the rate being asked for simple liability on his even simpler "Jaybird" seemed preposterously out of proportion to the damage his tiny plane could inflict.

It is said, however, that no good deed goes unpunished and complaints of this sort are not made without a certain amount of risk... One might almost label it "Don't Mess With The Lone Ranger." Since he

apparently infuriated the perpetrators of this hoax called the "EAA Insurance Program," the Editor has been informed that insurance is now not available at ANY price. The reason given is that the underwriter, **Global Aerospace**, had had a policy of not insuring auto engines in aircraft unless they were built up by a engine conversion shop on their "approved" list, and Scott Casler, d.b.a. "**Morey Hummell Engines**," is not on that list. At any rate, it was said that Global recently went against their own policy and issued a policy on a non-approved auto engine installation, the engine failed, and the pilot was "fatally injured." At this point, the Editor will quote from his reply to Falcon/Global/EAA:

"I require coverage for liability only; no medical, no hull, no passengers. Had this involved me and my single-place "Jaybird," where would Global Aerospace have any responsibility? In short, it appears that EAA, Falcon, and Global are willing to write insurance on a "sure thing" and a policy on an "un-proven" engine conversion and requested by a smartass from Florida is not worth the risk. Funny, but the writer thought that is what insurance was all about, risk.
